Limit should be given in multiples of thousand else lower rounding of thousand will be fixed as limit. If custom limit is greater than the domestic limit, domestic limit will be fixed as international limit. (6) If none of the option selected for any one of channel, international limit will be fixed as Zero limit. (7) Limit will be effect from 00:00 Hrs. IST of "Limit start date" to 24:00 Hrs. IST of "Limit end date". (8) Please ensure that "Limit start date" and "Limit end date" are future dates. (8) Application should be submitted at least three working days prior to "Limit start date". (9) After the expiry date of international card limit end date requested above, the card cannot be used for international transactions.
